

## Spivey Splash Water Park Splash Cabana and Umbrella Policies and Regulations



These Policies and Regulations are intended for the patron’s and guest’s protection and to ensure that all parties are aware of the privileges and liabilities associated with the use of the Cabanas and Umbrellas located at the Spivey Splash Water Park.

Please make sure that all persons renting a space have a copy of these policies and regulations. Failure to follow these policies and regulations may result in the loss of your deposit and/or additional charges being assessed to the patron.

1. **All rental fees are due at booking.** Spivey Splash does not hold dates. Reservations are issued to the first party to complete all required steps for making a reservation (This includes agreeing and signing this policy and regulation form, filling out the customer information form and paying all fees in full).
2. A patron will only be allowed to rent a total of 2 Cabana areas on one day.
3. Cancellations on all rentals must be done at least 48 hours prior to the rental date. Not doing so will result in the forfeit of the deposit. Email or written confirmation is required.
4. All payments must be made by cash or credit card.
5. **Rental time includes cleanup.** Patrons must be out of the park area at the designated time. Not doing so will result in the loss of the deposit and/or additional charges.
6. **No outside food and drinks are allowed.**
7. **Balloons, silly string, confetti, and glitter are not allowed in the Water Park or under any rental areas.**
9. The affixing of anything to the rental area structures with nails, staples, thumbtacks, or any other material that may damage them with holes are strictly prohibited.
10. Furniture and/or equipment shall not be moved or removed from the rental areas. If there is a problem with the layout of your area please notify a staff member of Spivey Splash.
11. All trash is to be placed into the trash receptacles. Liners within the receptacles shall not be removed.
12. Smoking/Vaping or the use of tobacco products, including, but not limited to, snuff and chewing tobacco are strictly prohibited at all locations within Clayton County International Park including Spivey Splash.
13. Alcohol is strictly prohibited.
14. Playing music- DJ, Live or otherwise in the Cool Canopy area is strictly prohibited.
15. You must leave the rental area in the same manner that you received it. By not doing so will forfeit your rental spot.
16. If you depart your rental area early, you are not authorized to grant access to the Cabana or Umbrella rental by another user. If you do so, you will forfeit your security deposit.
17. Clayton County International Park is not responsible for unexpected environmental conditions such as bugs, flies, mosquitoes, and/or bees at Cool Canopy and will not refund any portion of the rental fee based on this occurrence.  
**There are no refunds due to inclement weather.** If assistance is needed on the day of event, please speak with your designed Spivey Splash Water Park coordinator.
18. Please check in and out for your rental at the Cabana Kiosk located at the Splash Shop in the main building.

**I agree to abide by the policies and regulations stated above and acknowledge that I will be held responsible for any damage to or littering within the Complex. In such event, I agree to pay for any cost of time, cleaning, remedy, repair or other damages, which I authorize by credit card or other form of payment, to be debited accordingly.**
